



Chemical resistance test on

Ultracur3D® RG 1100 B

This document is intended to provide guidance for manufacturers regarding the compatibility of the 3D printed materials with hydrocarbons and cleaning chemicals. BASF 3D Printing Solutions GmbH has performed specific chemical test for the material Ultracur3D® RG 1100 B. Indications on material changes that can occur during the chemical test were studied. It remains the responsibility of the device manufacturers and/or end-users to determine the suitability of all printed parts for their respective application.

Used hydrocarbons and cleaning chemicals

Fluid
Acetone
Brake fluid
Cooling fluid
Engine oil
Hydraulic oil
Isopropanol
Multi purpose fat
Transmission oil

Test method and specimens

85 tensile bars were printed with the material and were soaked in each fluid, one set for 30 minutes and one set for 7 days. After the soaking time the parts were removed from the test fluid and were dried to measure the weight and the mechanical properties like E modulus, Tensile strength and Elongation at break.

Mechanical testing

Storage in the different fluids for 30 min only show prominent changes of the elongation at break. Acetone severely changes the values of all mechanical properties after 7 days of immersion, whereas the values for the storage in cooling fluid only show slightly changes. The same time in the other fluids leads only to prominent changes in Elongation at break. whereas the Tensile strength and E modulus are relatively stable.




Figure 2 Change in mechanical properties in chemical fluid for 30 minutes




Figure 3 Change in mechanical properties in chemical fluid for 7 days







Weight

All measurable samples show no difference in weight after soaking time, therefore no fluids were taken up by Ultracur3D® RG 1100 B.




Figure 4 Change in weight in chemical fluid
